SWA Membership Category Review 2019

In line with the SWA Strategic Plan 2019 – 2024, SWA Membership staff commenced a review of the current SWA Membership categories in early November 2018. The SWA Presidents were consulted at the December SWA Presidents' Forum at Beatty Park, and their feedback incorporated into the document that is being developed.

In line with the SWA Membership Review Strategy, a SWA Membership Review Working Group has been developed and held their first Teleconference on **Wednesday**, **30**th **January 2019**.

Key common themes that are emerging include;

U The importance of SWA Membership must be upheld

- We MUST address the misconception that it is about competitive swimming it isn't if you think about it.
- We MUST capture the Squad Swimmers at our Clubs and aquatic centres.
- SWA MUST NOT compromise what swimming is all about competing at some level in some form if only against yourself!

Optus Junior Dolphins Programme

- With the loss of Optus what now? What will the JD pack look like or will be there be one?
- The inclusion of the 8 year old category?
- Junior Dolphins can no longer be free for everyone.
- Do we offer 6 year olds Free Entry SWA and and Club?
- Can SWA run this programme on a state basis?

a 8 year old Membership

- Do they become an extension of Junior Dolphins? That is, Junior Dolphins now caters for 6 8 year olds.
- SWA to develop a a specific development programme tailored to assist in transition into competitive swimming.
- Splash & Dash Carnivals remain a key recruitment tool for Clubs MUST be a focus on conversion to Membership.







SWA Membership Category Review 2019

Key common themes that are emerging include;

Annual Membership

- Name change to 'Full Membership' as it reflects the intent of SWA and it's Clubs.
- Spilt categories to better reflect differing needs based on age.
- 2 price points (Junior/Age & Open) increase as the athlete moves from one category to the next, with 'value being added' to suit changing needs and interest as they move between categories? Discussion.

Seasonal Membership

- 1 category from 9 years up.
- Must add more value to arrest the decline importance of Regional Meets.
- Westpac Summer League can significantly grow Seasonal Membership across Regional WA.

General Membership

- Fitness & Training Squads; a gap in the market to be captured.
- Seen as a strong recruitment tool: "I never compete, but I will continue to train with my Club".
- Insurance is important, no matter what level of participation.
- Club Support for this category, whilst ensuring competition remains priority objective.

All systems go, but why change what is already in place?

- Change attitudes and improve retention focusing on long term athlete development
- ➤ Overloaded WA competition calendar resulting in:
 - Consolidate the competition calendar
 - Increase purpose and clearer objectives
 - Considerable competition pressure on swimmers, coaches, parents and Technical Officials
 - Acknowledgment that sometimes CPC doesn't get it right!
- Manage the planning for the Zone/Regions and make local decisions
- Provide opportunity for volunteers to up-skill on governance, competition delivery skills

- Empower the Clubs and Zones/Regions and allow them to increase their earning potential to financially support Zone Clubs
- Zone/Region Championships a good step forward for retention
- Improve junior development programme offering (high level of commitment and intensity for junior swimmers considered by many to be detrimental)
- > Swimming Australia Junior Participation Guidelines
- ➤ Lack of interclub rivalry
- Sport is hidden at HBF Stadium and lost the local suburban connection e.g WACA
- \succ To grow the sport, we must go back to the community
- ➤ Improve sanctioning guidelines
- ➤ Lead as a governing body, not an events company







Competition Model





Outcomes from Metro Zones consultation

- Club placement into each zone agreed by each Zone
- Concern regarding the seating at venues, equipment, weather, venue operator support
- Outdoor venues following Vic Park lead
- Splitting senior and junior Zone qualifying meets or not offering full programme each Meet to keep event length at manageable
- Various membership numbers in Zones, meaning less earning potential for some Zones through their competition cap on entries or maximum entry fee per event
- SWA investigate Incorporation fees and receive reimbursement through a sanctioning fee from first Zone competition
- Concurrent Zone events and TO availability
- The use of HBF Stadium
- Zone Champs relays on offer
- Zone Champs minimum qualifying standards but suggestion that there should be a maximum?
- MC Members able to enter any Zone qualifying meet or Zone Championships (register as visitor?)



What does this mean for Country swimming?

- Increased focus on engaging and supporting Region Committee and structures
- Assist Regions to make local decisions in best interest for their local Members
- Strong engagement with and support from State Gov
- New qualifying meet in each Region, with SWA hands on support, to engage Region members and encourage all to attend
- Encouragement of Region members to engage more within their Regions and enjoy Metro based competition also i.e. SunSmart Summer Club Clash, Asia Pac Super Splash
- Continued introduction of Junior Dolphins, SunSmart Splash & Dash, Westpac Summer League, which has proven very popular and successful this year.



Where do we start? A draft plan. Year One

- All Metro Zone & Country Region Committees have an executive of at least 3, with supporting general committee (all Clubs represented by 1 delegate with voting rights), a SWA Advisor and meet 4 times per year.
- 2) Incorporation occurs & bank accounts set up for Zones/Regions not already established
- 3) I Metro Zone & Country Region based gualifying meet hosted in early Summer season to replace SWA Season Opener (SWA provide meet template – closed to the Clubs within the Zone/Country Region)
- All Metro Zones & Country Regions host a Zone/Region Championships 4)
- 5) Zone Championships time of season TBD
- Metro Zone/Country Region collects revenue from qualifying meets & 6) Zone Championship to invest back into the Metro Zone/Country Region Clubs over time.
- Implement age group bandings for State Championships from Winter 2019)


