8. SPECIAL RESOLUTION

The explanatory message to Members regarding the proposed Special Resolution was reiterated by Mr. Michael.

The Swimming WA Board reviewed the current Constitution of the Western Australian Swimming Association Inc. and identified the following issues:

- The current Constitution needs to comply with all of the requirements of the Associations Incorporation Act 2015 (WA) (Act) which details certain matters which must be addressed in an Incorporated Association’s Constitution.
- The current Constitution does not meet all the governance requirements of the Department of Local Government, Sport and Cultural Industries (DLGSC). Failure to meet these governance requirements will adversely impact Swimming WA’s DLGSC grant funding.
- The current Constitution is confusing in parts and contains duplication of various matters in the By-laws; and
- The current Constitution does not meet all the requirements of the Swimming Australia Constitution which is currently being updated.

Following considerable consultation with our members, Swimming WA would like to move the following motion:

“That the Constitution, in the form presented to the Annual General Meeting by the President of the Western Australian Swimming Association (Inc.), be adopted as the Constitution of Swimming WA Inc. in substitution for and to the exclusion of the existing Constitution of the Western Australian Swimming Association Inc.”

Mr. Michael requested a show of hands from eligible Delegates for the acceptance of the Special Resolution.

Carried: 24 voted to accept the Motion, achieving more than the required 75% of delegates in attendance and therefore the Motion was carried.

9. CONFIRMATION OF ELECTED DIRECTORS

Mr. Michael addressed the meeting, stating that the number of nominations received for the two (2) vacancies of Elected Director and there were two nominations were received. Therefore, the following two Directors are duly elected for three-year terms.

Mr. Michael welcomed Ms. Fulham and Ms. Ryan to Swimming WA Board and left the Membership and joined the SWA Board.

OUTGOING BOARD MEMBERS

Mr Michael informed the meeting that Mrs. Dot Harris completes her tenure on the Swimming WA Board as of today. Mrs. Harris was first elected to the Board in 2002 before standing down in 2010 and was then re-elected in 2011 and has now been on the board for over 20 years. The Swimming WA Board sincerely expresses their gratitude to Mrs. Harris for her contribution and service over such an extended period of time.

Mr Michael also informed the meeting that later in the month Appointed Director, Dr. Tommaso D’Orsogna will not be seeking reappointment and that the position left vacant will be duly filled. However, Dr. D’Orsogna will continue his involvement in Swimming WA through remaining on SWA committees.

Mr. Michael thanked Ms. Dorothy Harris and Dr. Tommaso D’Orsogna, for their contribution to swimming and time served on the Board.

10. LIFE MEMBER NOMINATIONS 2022

Mr. Michael informed the Membership that the purpose of awarding SWA Life Membership was to acknowledge the dedicated and selfless contribution of persons who have provided extensive years of voluntary service to SWA. Under Section 6.3 of the Swimming WA By-Laws, the Honours and Awards Membership Committee will consider nominations for Swimming WA Life Membership to the organisation in advance of the AGM with any recommendations to come to the AGM for ratification.

For 2022, Swimming WA received two nominations for SWA Life Membership for the SWA Honours and Awards Committee to consider. It was considered that both nominees met the criteria.

Mr. Michael expressed that Ms. Jan Smith has, and continues to, dedicate a huge amount of time to the successful management and operation of swimming events at both a local, regional, and

state level in Western Australia. Ms. Smith started her journey as a parent, timekeeping at York Friday Club Nights, like many involved in swimming. Over her 30 years involved in the sport, Jan has been a York Swimming Club Life Member, Regional advocate, and country swimming supporter.

- York Swimming Club Secretary and Committee Member (current)
- Technical Official (starting as a District Referee)
- Club Delegate of the Region
- Secretary for the Region
- Region Coordinator
- Country Coordinator (2003-2014, voted by Country Clubs, and again 2019-current)
- Overseeing 11 Country Pennants and Country Championships as an official

Her contribution to Swimming WA and regional swimming has been phenomenal. Her skills and consistent presence on the pool deck and within the Western Australian swimming community is to be admired.

Mr. Michael detailed that Mr. Joshua Hofer OAM has used the platform his international and national achievements have provided him with to positively promote the sport of swimming, especially within the multiclass swimming community. Mr. Hofer's willingness to travel the state and show off his medal and trophies to inspire the next generation is something to be commended and rewarded and am sure, has given many athletes the confidence to attempt competitive swimming. Mr. Hofer's experience in the sport has contributed towards the many positive changes through his involvement in several committees over the years, including the Perth City Swimming Club committee for 5 years and then as the Perth City Swimming Club captain for 2 years as well as Ambassador for Swimming WA for three years. Mr. Hofer continues to champion the sport of swimming across the state, dedicating his life to swimming.

Mr Michael proceeded to ask for the ratification of the Members Life Membership for Jan Smith and Joshua Hofer.

Mr. Michael requested a show of hands from eligible Delegates for the acceptance of the Life Memberships.
