### SPECIAL RESOLUTION

Carried: Votes were counted. There were 19 votes, with 17 votes supporting the Motion, two votes against the Motion and one abstention, thereby achieving more than the required 75% of delegates in attendance. Mr. Michael announced that the Resolution was carried with a majority vote.
