#### **VOTING METHOD**

In accordance with the SWA Constitution (11 May 2019), Section 23, Clause 23.2 (e);

"If the number of nominations received for the Board is equal to the number of vacancies to be filled or if there are insufficient nominations to fill all vacancies on the Board, then those nominated shall only be duly elected".

Should there be more than two (2) nominations for the vacant Elected Director positions, SWA Constitution Section 23, Clause 23.2 (f) shall apply;

"If the number of nominations exceeds the number of vacancies to be filled, a secret ballot shall be taken in such usual and proper manner as provided by the Constitution and By Laws."

In that eventuality, the SWA Board has determined that votes will be received by, and counted by, an independent third party and it has appointed Elections Australia Pty Ltd. to manage the online voting process.
